The first concert: was held at the KAFM's Radio Room, 7:30 pm on Wednesday the 13th. This is a small venue but was perfect to simulate a small, intimate jazz club.

There were 46 students divided into five combos (according to age/level of accomplishment). This year's enrollment represents a 60% increase over last year's. Approximately 70% of the students were first timers to the camp. Each combo performed from one to 3 musical numbers with numerous solos featuring every individual at one time or another.

Credit was given to the Commission in the introductory remarks leading up to the performance and our logo was on the Jazztopia T-shirts that the students, instructors and adult "roadies" wore.

On Tuesday, Darin and John Riley were on KAFM for a 15-minute segment of the community affairs

program. They both gave mention of the Commission's support for Jazztopia. This public affairs segment was a good opportunity for the listeners to learn more about the program. I suggested to Darin that he should plan to do it every year but earlier in the season to alert more students about the camp and more adults about the

performances. Jazztopia was also publicized on the KAFM website and has been mentioned on KAFM's Community Arts Calendar for the past several days, five times a day.

I estimate that there were 55+ attendees in the audience. The suggest donation was \$10 for adults and \$5 for children. 50% of the gate went to Jazztopia and the remaining half went to KAFM.



The quality of music was surprising considering that the kids only had three days together. Darin had the help of ten assistants who were each assigned to one of the combos. John Riley instructed the most senior group and you could tell that he had been giving "his" students tips on jazz style and improvisation.



The second concert: was the afternoon Dress Rehearsal – 3:30 pm, Thursday, at Moss Performing Arts Center, CMU. There were approximately 150 people in attendance. The students ran through their numbers and the audience seemed quite appreciative of the music.



John had a chance to speak with Darin

prior to the performance. He gave me more details on the camp curriculum. The students spend four days studying major points of jazz including history, composition, improvisation and instrument mastery. According to Darin, this camp, now in its sixth year, has built an excellent reputation in the state.

3rd concert: The Jazztopia Performance,

Jazztopia with John Riley and the Western Colorado Jazz Orchestra was well attended and a wonderful example of the level of Jazz musicianship in the valley. The smaller combo consisted of John Riley and some



of the workshop instructors. They played five songs spotlighting the different instruments to standing ovations.



The Western Colorado Jazz Orchestra played several jazz standards featuring various instruments such as the Baritone Saxophone, Tenor, Trumpet, piano and drums. Dr. Kamstra thanked the GJCAC nicely between performances. There was no program for this event.

POCs: Dr. Darin Kamstra and Trish Weber were very communicative and helpful. The instructors are very passionate about helping kids to find their Jazz voice.

<u>Weaknesses</u> none noted other than not having a program which wasn't that important as they announced the songs.

Strengths: Overall, I think this is an excellent program. The increase in enrollment clearly demonstrates that the camp is gaining a very positive reputation. From talking to a couple of the students, it was obvious to me that they were enjoying themselves and were fueling their interest in jazz. Bringing a master-level performer such as John Riley was such an inspiration to the students and faculty. John plays with the Vanguard Jazz Orchestra which is a multiple Grammy Award-winning 16-piece jazz orchestra, comprised of a Who's Who of New York City's finest musicians. The nightclub opened in 1935 and became a Jazz club in 1957.

<u>Description:</u> The Summer Shakespeare Series of Much Ado About Nothing by the Geek Parties of the Grand Valley was a contemporary adaptation of the comedic play using traditional Old English, some modern costumes and phones for props. The full plays were held in a room in the back of Edgewater Brewery. It was a simple set at the back of the room with minimal set changes and some costume changes. One of the members narrated from the back during the performance to cue the audience to different settings or scene changes. He was hard to hear.

The Strengths: Up arriving we were greeted promptly and kindly, given a playbill and a pencil with a line

from the play. The room was pretty full so we shown to open seats. All participants seemed very engaged and into their character roles and happy to be there. Food and

drinks were available from the establishment during the performance. The audience was receptive and seemed delighted with the play. The parts seemed well cast and the playbill was well done. It had a game for the audience to complete and a page for autographs. The biggest plus was that the cast was very enthusiastic. Edgewater Brewery was very receptive including having a drink special with drinks such as Much Ado, Plain Dealing Villain and more.

They thanked and announced partial funding by the GJACC. The cast included

young and old, with a 12-year old giving a fine performance.

<u>The Weaknesses</u>: Some performers stumbled over lines or referred to a phone in hand or script. Cell phones may have been a deliberate tool, but was not effective as the cast was constantly looking down at their phones which does take away from the overall performance as very little facial expressions are used when reading lines(no audience eye contact). We had a hard time hearing the dialogue. They stated they needed mics and hoped to purchase some in the future. There was some distracting noise from the Kitchen but the staff were trying to be quiet once the play started. Also, the dress was more like ones used for a rehearsal.

<u>Suggestions to improve the event</u>: Mics on some of the quieter characters, memorize lines or mostly do so. Give a little more information on the game. I've asked for information on KAFM's ads or aired segments on the radio to be included in their presentation. Send free KAFM tickets at least a week before the event. It would have been helpful to have had them earlier to give to another commissioner since it was the same night as Jazztopia.
