Summary of Written Comments FOR Ballot Issue No. 4A:

1. Voting Yes on 4A will replace Grand Junction High School. Built in 1956, the school was constructed on an unsound foundation and is literally sinking into the ground. It is past time we replace the school to provide kids the education they deserve with modern classrooms that prepare them for the jobs of the 21st Century.

- 2. Voting Yes on 4A will secure all four high schools. Safety is a top priority in schools today and voting Yes on 4A will eliminate more than 120 non-secure entrance points district-wide. By bringing all academic buildings under one roof, each high school will have a single, secure point of entry and exit the most effective way to stop unwanted, dangerous intruders into our schools.
- 3. In addition to securing all four high schools, 4A will conduct core infrastructure repairs in Central, Fruita, and Palisade high schools to extend the lives of each school another 25 years.
- 4. 4A is a smart financial investment. Summary of Written Comments FOR Referred Measure 2A:

Ballot Issue 2A asks for permission from city voters to bond for needed transportation projects without raising taxes. The bonds will be paid off in the future with funding that is currently dedicated to retiring the Riverside Parkway debt. That debt will be paid off between 2022 and 2023 and uses a combination of general fund dollars and funding from a TABOR override that has been in place for 11 years.

Reasons to vote for this measure include:

- Traffic congestion is increasing as we continue to grow as a community and will only get worse if we wait.
- Where the money will be spent is clearly defined. Projects that will be funded are listed in the ballot question and include adding new roads, addressing congested areas and making routes to schools safer for children.
- Bonding has been used before in our community to fund major transportation initiatives which are needed now but could take years to complete if we waited until we had the cash to fix them.
- Our dollars will go further as we can complete these needed projects at today's costs for construction versus what those
 costs might be in ten or fifteen years.
- Interests rates are still low so our cost of financing will likely be lower now than if we wait to do this sometime in the future.

In conclusion Ballot Issue 2A is not a tax increase. It is a request by the City of Grand Junction to bond for \$70 million in order to help alleviate traffic congestion, insure safer routes to school for elementary students and meet the needs of a growing community.

Summary of Written Comments FOR Ballot Issue 6A

The District and its fire department are run completely by volunteers. Your tax dollars are only used for equipment, supplies, and operating expenses. Your tax dollars are currently not used for salaries or wages of any type. Increasing the District's tax levy to 6.5 mills will enable the District to remain in business, and will provide stable and predictable revenue for the District to meet the community's increasing demands for emergency services. Approval of the requested property tax increase to 6.5 mills will result in projected total yearly property taxes to a home in the District as follows:

\$100,000 Actual Value for a Residence = \$46.48 per year \$200,000 Actual Value for a Residence = \$92.96 per year \$300,000 Actual Value for a Residence = \$139.44 per year

The District has looked carefully at the District's future needs and the current tax revenue will not be enough to provide services to the District's residents.

Our 49-year-old tender supplies a 3,000-gallon water sources to homes and property that are not close to a fire hydrant. This vehicle is functionally obsolete, and if it breaks down, the District may not be able to repair it.

The District would like to provide a small retirement benefit to eligible volunteers who have met certain minimum requirements. This benefit should help the District recruit and retain volunteers and provide some incentive for District volunteers to do this community service work that is both demanding and dangerous.

The District needs to replace personal protection equipment such as Self-Contained Breathing Apparatus (SCBAs), radios, personal protection clothing and other firefighting equipment. Current Federal laws require the District to replace some of these items after approximately 10 years.

The District would like to hire an independent contractor to assist with the administration of the department and District. New laws and regulations create compliance issues for the District.

The Taxpayer's Bill of Rights (TABOR) is one of the most significant and complex laws that applies to special districts such as the District. TABOR is a provision of the Colorado Constitution (Article X, Section 20) that prohibits government entities, including special districts, from incurring multiple fiscal year financial obligations without voter approval, and it imposes tax, debt, revenue and spending limitations.

Voter approval of this measure will allow the District to keep and spend all the tax revenue, it receives each year and any other revenue it may obtain through grants, donations or other sources and carry over any unspent revenue to the next year. This will allow the District to budget money over multiple years to replace aging equipment when necessary. Without this approval, the District would have to go into debt and pass a bond issue to purchase expensive capital items.
