# HEARING OFFICER SAM D. STARRITT

### I. CALL TO ORDER

The meeting was called to order at 2:00 p.m. Those present were Hearing Officer Sam Starritt, City Attorney John Shaver and Deputy City Clerk Selestina Sandoval.

Hearing Officer Starritt read the renewals into the record and verified with Ms. Sandoval the applications were in order. Hearing Officer Starritt asked if anyone was present to speak against any of the renewal applications. There was no one. Renewal applications #1 through #7 were approved.

Members Tara L. Geery and Chad Geery were present to answer questions about the Transfer of Ownership application. Hearing Officer Starritt asked if anyone was present to speak against the application; Jim Hamilton, manager for the apartment complex next-door expressed concerns over noise violations at that location in the past. Ms. Geery told the authority that they are already taking steps to avoid excessive noise, especially at the outdoor patio area. Hearing Officer Starritt stated that Mr. Hamilton's concerns, although valid, were not enough to deny the application and encouraged him to communicate with the new owners and law enforcement, and cautioned Mr. and Mrs. Geery to be cognizant of the noise levels at Scallywags Bar and Grill. The application for transfer of ownership was found to be in order and approved.

Ms. Sandoval reported the paperwork was in order and read the results of the survey (attached). Managing Member Paul G. Romero introduced those present that helped conduct the survey, Jessica Martinez, Roberta Manzanarez, and Mary Romero, and answered questions about how the survey was conducted.

Hearing Officer Starritt said a sufficient number of businesses signed the petition, but more residential signatures were needed. He continued this application to the November 20, 2019 Liquor and Beer Meeting in order for the applicant to get more residential signatures on the needs and desires petition.

2. Natures Revival, LLC dba Natures Revival, 683 Horizon Drive #101, Grand Junction, CO 81506, Lodging & Entertainment

Ms. Sandoval reported the paperwork was in order and read the results of the survey (attached). Members Yi Liu and Sanmei Zhang answered questions about their business plan and the application to serve alcohol at the establishment. Questions

were asked in regards to when and where alcohol would be served, the licensing of employees and the services offered at Natures Revival.

Mr. Liu also answered questions about how the survey was conducted. Hearing Officer Starritt noted no signatures had been obtained in one area of the designated neighborhood. Hearing Officer Starritt continued this application to the November 6, 2019 Liquor and Beer Meeting to allow Mr. Liu time to seek petition signatures in the area south of Horizon Drive. Hearing Officer Starritt also requested copies of licenses of all employees offering services that require one to be sent to the City Clerk's office.

The application for a special event permit submitted by Colorado Mesa University Foundation for the "Great West Beer Fest - 2019" was in order and approved.

To date, no letters of opposition or counter petitions have been filed.



Only attendees 21+ will be allowed to attend. All attendees will be age verified and wristbanded upon entering. Once attendees are verified trained servers will be pouring beer and monitoring intoxication. course, to attendees who are no marked on both hands. The Citadel officers will be positioned at each entrance and excit point throughout the event to insure no alcohol leaves or enters the premise. The 8 uniformed officers as well as trained staff will monitor intoxication and conduct, these staff members are Tips or safe server trained.

8. How will security personnel be identified?

Security will be in uniform. Staff will be in recognizable t-shirts.

9. If this event is being held outdoors, how will the exterior boundaries of the premises be marked (i.e., roped, fenced, etc.)?

The event will be held inside. Please see attached map for details on the Maverick Pavilion.

10. What method will be used in checking identification for proper age of attendees (i.e., at the door, at the bar, etc.) and how will underage patrons be identified so as not to be served alcohol beverages (i.e., stamp or mark on the hand, etc.)

No patrons under 21 will be allowed to enter.

11. How will the conduct and level of intoxication of attendees be monitored and by whom?

Conduct and intoxication will be monitored by the trained staff and uniformed secuity guards.


