#### **RECOMMENDATION:**

Staff recommends adoption of Resolution No. 5-2019 adopting the 2020 Recommended Budget for the City of Grand Junction Dos Rios General Improvement District.

#### **EXECUTIVE SUMMARY:**

The purpose of this item is to adopt the budget for the City of Grand Junction Dos Rios General Improvement District.

#### **BACKGROUND OR DETAILED INFORMATION:**

The City of Grand Junction Dos Rios General Improvement District (GID) was established by Grand Junction City Council in July of 2019. The City Council is the ex officio Board of Directors of the GID. The GID is authorized to make improvements to and provide services within the GID boundaries including but not limited to; acquiring, constructing, installing, operating and maintaining utilities, roadways, trails, sidewalks, parks and open space. In order to fund those improvements and services, the GID is authorized, if approved by voters, to issue debt and levy taxes.

On November 4th, 2019 the GID voters authorized the GID to impose a mill levy and issue debt. The plan for the GID is to contract with the City of Grand Junction to construct \$10.9 million in infrastructure in the GID.

#### FISCAL IMPACT:

The proposed budget is outlined in Attachment 2.

#### RESOLUTION TO ADOPT BUDGET

WHEREAS, the Board of Directors ("Board") of City of Grand Junction Dos Rios General Improvement District ("District") has appointed a budget committee to prepare and submit a proposed 2020 budget to the Board at the proper time; and

WHEREAS, whatever decreases may have been made in the revenues, like decreases were made to the expenditures so that the budget remains in balance, as required by law.

- 3. That the budget, as submitted, amended and herein summarized by fund, be, and the same hereby is, approved and adopted as the budget of City of Grand Junction Dos Rios General Improvement District for the 2020 fiscal year.
- 4. That the budget, as hereby approved and adopted, shall be certified by the Treasurer and/or President of the District to all appropriate agencies and is made a part of the public records of the District.

#### TO SET MILL LEVIES

WHEREAS, the amount of money from property taxes necessary to balance the budget for general operating expenses is \$0; and

WHEREAS, the amount of money necessary to balance the budget for debt service expenses is \$0; and

WHEREAS, the estimated 2019 valuation for assessment of the District is \$211,529.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of City of Grand Junction Dos Rios General Improvement District:

- 1. That for the purpose of meeting all general operating expenses of the District during the 2020 budget year, there is hereby levied a property tax of 0.000 mills upon each dollar of the total valuation for assessment of all taxable property within the District to raise \$0.00.
- 2. That for the purpose of meeting all debt service expenses of the District during the 2020 budget year, there is hereby levied a property tax of 0 mills upon each dollar of the total valuation for assessment of all taxable property within the District to raise \$0.
- 3. That the Treasurer and/or President of the District is hereby authorized and directed to immediately certify to the County Commissioners of Mesa County, Colorado, the mill levies for the District as hereinabove determined and set, or as adjusted, if necessary, upon receipt of the final (December) certification of valuation from the county assessor in order to comply with any applicable revenue and other budgetary limits.

#### TO APPROPRIATE SUMS OF MONEY

WHEREAS, the Board of Directors of the City of Grand Junction Dos Rios General Improvement District has made provision in the budget for revenues in an amount equal to the total proposed expenditures as set forth therein; and

WHEREAS, it is not only required by law, but also necessary to appropriate the revenues provided in the budget to and for the purposes described below, as more fully set forth in the budget, including any inter-fund transfers listed therein, so as not to impair the operations of District.

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of the City of Grand Junction Dos Rios General Improvement District that the following sums are hereby appropriated from the revenues of each fund, to each fund, for the purposes stated in the budget:
