ORDINANCE NO. 2

AN ORDINANCE AUTHORIZING THE ISSUANCE OF BONDS OF GRAND JUNCTION GENERAL IMPROVEMENT DISTRICT NO. 1 FOR STORM SEWERS, GRAND JUNCTION, COLORADO, FOR THE PURPOSE OF THE CONSTRUCTION OF A STORM SEWER, STRUCTURAL APPURTENANCES THERETO, AND NECESSARY STREET REPLACEMENT TO PROVIDE FOR THE DRAINAGE OF LANDS WITHIN THE DISTRICT; PROVIDING FOR THE LEVY OF TAXES TO PAY SUCH BONDS AND THE INTEREST THEREON; AND DECLARING AN EMERGENCY.

WHEREAS, at a special election of the taxpaying electors of Grand Junction General Improvement District No. 1 for Storm Sewers, Grand Junction, Colorado, duly called and held on the 27th day of April, 1962, in accordance with law and pursuant to due notice, such electors did, by a vote of 99 ballots "FOR THE BONDS" and 7 ballots "AGAINST THE BONDS", carry in the affirmative by a majority of 92 ballots the question of issuing bonds of said District in the sum of \$113,000.00, for the purpose ^{of} the construction of a storm sewer, structural appurtenances thereto, and necessary street replacement to provide for the drainage of lands within the District; and

WHEREAS, the returns of said election were duly canvassed and the result thereof duly declared; and

WHEREAS, said bonds were duly advertised for sale, and on May 2, 1962, \$113,000.00 of said bonds were awarded to
