QUESTION SUBMITTED: Shall the City of Grand Junction for the consideration of \$1.00, sell and convey to the Mesa County Veterans' Association the following described property situate in Mesa County, Colorado, to-wit:

Beginning at a point from whence the Northeast corner of the Southwest Quarter of the Northwest Quarter of Section 26, Township 1 South, Range 1 West of the Ute Meridian bears due East a distance of 917.0 feet; thence Southwesterly along a curve whose radius is 228.6 feet and whose Central Angle is 133°41.6' for a distance of 472.8 feet, thence along a curve whose radius is 65.0 feet and whose Central Angle is 118°00' for a distance of 133.9 feet, thence North 16°24' East 84.5 feet, thence Due East 20.0 feet, thence Due South 147.5 feet, thence Due East 100.0 feet, thence Due South 19.5 feet, thence Due West 210.0 feet, thence North 45°25' West a distance of 287.8 feet, thence Due North 238.0 feet, thence Due East 268.2 feet to the place of beginning, subject to existing easements and road rights-of-way.
