MAIL BALLOT VOTING INSTRUCTIONS

Step 1: Make your choice for each contest from the official ballot on the inside of this page.



Step 2: Unfold your punchcard and put it on a hard table top. With tip of a pointed instrument (ie., the end of a toothpick or an unbent paperclip), punch out the dot in the numbered box on the ballot card that is the same as the number of your choice for a candidate, Amendment or Referred Measure.

SAMPLE

"SHALL ARTICLE II, SECTION 38, OF THE CITY CHARTER BE AMENDED TO READ:

38. Salaries - At least two meetings of the City Council shall be held monthly at such times as may be fixed by the Council, such two meetings to be known as the regular meetings. All other meetings of the City Council shall be known as special meetings or adjournments. The President of the Council shall be paid a salary of \$750.00 per month and all other Council members shall each be paid a salary of \$500.00 per month.
