Item 2: Approval of Minutes

Dr. Scott McBrayer moved to approve the March 14, 2013 Parks and Recreation Advisory Board minutes. Scott Coleman seconded. The minutes were approved unanimously.

Item 3: Las Colonias Master Plan

Rob Schoeber provided a short history on Las Colonias Park, stating a year ago City Council gave approval for staff to move forward with revisions to the master plan. A stakeholder group has since been formed, consisting of representatives from Western Colorado Botanical Gardens, Riverfront Commission, Tamarisk Coalition, Lions Club, City Council, and City staff. The most significant change to the previous master plan is the omission of the recreation center, as the direction is now to develop the property as a "passive" recreation park.

Traci Wieland showed a PowerPoint presentation on the proposed Las Colonias master plan (See attached). A public meeting was held, in which approximately 75 people attended and provided positive feedback. At this time, the group is researching a multitude of grant opportunities and working towards obtaining final cost estimates. The current plan will be used as a "road map" for the next several years, providing a direction to go should funding become available for development. The hope is to start some aspects of the development later this year, although nothing has been decided at this time.

Dave McIlnay moved to approve the proposed Las Colonias master plan. Scott McBrayer seconded. The motion was approved unanimously.

Item 4: Project Updates

Rob Schoeber stated he had recently met with the Police Department and other agencies regarding the growing concerns about the high level of alcohol use at Emerson Park. In response, an Administrative Order declaring Emerson Park an "alcohol free zone" has been implemented effective immediately. Signs have been posted and the Police Department has begun enforcing the new regulation.

Traci Wieland provided an update on various park projects (See attached). The Lincoln Park entrances have now been paved and the existing crosswalk on 12th Street is currently in the process of being moved. The local marble club is celebrating Marble Day on June 4, with hopes the relocation of the marble rings will be completed in time for their event. The tennis and pickle ball court bids are going out soon, and the hand rails on the west side of the stadium have now been installed and will be painted before graduations.

Item 5: For the Good of the Community



I am a little concerned about a commercialization of the park with a zip line. Should promote walking and I am here to present the case of a contemporary concrete skate park. I understand the close proximity of the Orchard Mesa park. However, from my and my most avid skateboarder's perspective, that is <u>Not</u> a skatepark, which is built to a scale that makes it functional for High Level Skating and is not a destination park. It does fine as a novice park for children, but not much more. I propose either the festival grounds or eastern most overflow parking to be used. I cannot stress enough the importance of a reputable skatepark company to be contracted for the site design for the sake of park flow and usage. My vision is to use a part of this space to build a <u>destination</u> park which works for both local children and traveling adults much like the "lunch loop" has done for bicyclists. I would love to offer any help needed, I can provide info for skatepark grants, reputable builders, case studies, community support and so on. I would be more than happy to answer any and all questions and I look I feel a concrete skateboard, roller skate, scooter type park would be a fantastic addition to this park. These types of parks are often pushed to the side of the park and looked at in a negative light. However, there are several of these types of parks that have proven to be a very beneficial attributes to the surrounding areas if done right and actually included into the main focus of the park and not tucked away or hidden in the shadows

General Comments

Interesting, it all looks unbelievable! What and awesome attraction for families/ tourists. The zip line will get a great view and odor of <u>SEMI TRUCKS</u> !! That is a major, sad flaw in the plan. <u>Buy it!</u> (Brady Property) <u>Duh</u>! Please- drinking fountains and covered bench seating interdesperced. Please include adequate drinking fountains at multiple locations throughout the park. Some sheltered-covered park bench seating at various locations would be good. Consider including picnic tables scattered throughout, to encourage users to linger- artists to Picnic area? Covered, open uncovered and grassy.

I strongly support the overall design/ intent of the park! It will provide a great attraction to the City and Riverfront Trail. The overall design should emphasize natural/ native plantings requiring the least amount of

a slalom park is a nice feature for river enjoyment. It doesn't have to be a whitewater park for boaters to practice skills and enjoy the river. Are you familiar with the wonderful park that is right downtown Salida? What a nice feature for the town folks and tourists alike.

As you probably know, there has been talk in the past of creating 4-5,000 seat arena both for entertainment and possibly sporting events down in the Las Colonias area. It seems to me that at least looking in to the idea of a privately-financed facility that could be used year-round(indoors) makes more sense and could be done earlier perhaps, than a publicly-funded festival grounds that would have a limited season. Also, there is a lot of open space that is a little less valuable that would be just as well suited to festivals, such as Matchett Park(much geater capacity, too. There is also an existing dog park and again, the land is too valuable for that use, I believe. The master plan for Los Colonais Park is very well thought out and should be an asset the Colorado River riparian area. My vision for the open spaces can be restored to a riparian area that will attract birds and other wildlife. I have spent the last 12 years restoring a former gravel pit on Dike Road for Grand Valley Audubon Society. The area had been neglected after Mesa County abandoned this mining site and was over grown with non-native plants. The soil was saturated with salt to the point that not even weeds would grow. After over \$200,000 and thousand of hours of volunteer hours spent on the property it is starting to look like a wildlife area. Wildlife and birds are beginning to return to the area. It will take years before it will look like the smaller areas that was not ever disturbed. I believe that the city planners can benefit from our experience turning a dead zone into a wildlife area. I would like to be included in the planning for the landscape in the area outside of the planned

Comments Given to Staff

We need to have a spot where people can practice 'rolls' in their Kayaks. This would need to be an area with very slow moving or still water that is about four feet deep. I think the final irrigation pond that we pump out of would work well for this application.

aspects of the park

Lots of support for the Dog Park – all noting they liked having a lake in the Dog Park as well as maintained turf I got a good suggestion to consider using water cannons within the native grass areas as opposed to installing significant underground systems. This could greatly reduce initial costs, but increase initial maintenance

Numerous people were anxious for the private properties (Randall to brew pub, and north edge of parkway) to redevelop, and recognized that this project would be the catalyst to make that happen sooner

I only had to explain the radon/ammonia issues to one attendee

Most expressed that the Amphitheater was long overdue

There should be a woodchip walking/jogging trail circumnavigating the park with various cutoffs. A model for this type of trail can be found in the Eugene, Oregon, park system. It's called "Pre's Trail". I currently jog around Canyon View Park in the soft grass even though I live in Orchard Mesa. Canyon View's dirt trail is too hard packed to minimize injury so I run in the grass. The cement trail that now circumnavigates Canyon View is wonderful for walking and my wife and I use it frequently. Being able to circumnavigate the park is much better than an out and back trail. A woodchip trail at Las Colonias would be soft enough to allow beginner joggers to jog with minimal risk of injury. I cannot understand why a large amphitheater should be built in the park along with all the parking it will require. It's use will be minimal compared to park attractions that could be put in this space. Parks should encourage people to an active life style, not encourage them to sit on their fannies and watch entertainers. I recommend removing the amphitheater and replacing it with an obstacle course for adults to use at any time. Special events could be held at the adult obstacle course in combination with the woodchip running trail. Las Colonias could become a famous park like Eugene's Pre's Trail, but only better, because we would have an adult obstacle course. These challenging courses have excellent safety records. Lincoln Park Renovation


- The east entrance into park between Administration and the Golf Course and the 12th Street entrance have been paved.
- The existing crosswalk on 12th Street west of Stocker Stadium will be moved south and a median will be added. Upon completion of the crosswalk, crews will install an eight foot sidewalk on the east side of the track fence and entrance into the stadium. Work is scheduled for May with hopeful completion by JUCO (see page 2 and 3).
- The marble rings will be relocated northeast of the current location in an effort to provide a stage area for events. The new rings will be poured with the crosswalk and sidewalk project. The Grand Junction Lions Club will be participating in a "Marble Day" with the marble club on June 4.
- New signage has been ordered for the park including entrance and regulation signs, and crews are currently designing and scheduling a complete renovation of all existing landscape and planting beds.
- Tennis/Pickleball court bids were reviewed by user groups and are scheduled to go to bid mid-May with construction taking place mid-June through mid-September.
- Safety upgrades are underway at Stocker Stadium and will be completed by May 10.
- Bid specs are being developed for the Stocker Stadium track overlay and repair.




- Still waiting to hear about the planning grant through GOCO. Notification will be received in June.

- Bids were received for OM Pool Locker Room, LP Pool locker room, OM Plaster, and OM Deck. Between all four projects and the remaining ADA funds, the projects will be completed as scheduled this fall.
- Request for proposals are being developed for trail repair on Watson Island and three sections of the Blue Heron Trail.
- Final playground selections were made for Pomona Elementary and Washington Park (see page 4). Installation will take place this summer.

In regards to the question you asked, where to put the handicap parking lots, I believe the cut in spots off of Gunnison would be the best idea. After looking at the place that you pointed out, that people would have to reverse out of, it would make me nervous about running over a small child backing up for such a long distance.

I also wanted to let you know what a difference Rocket Park and now Lincoln Park has made in my life, and hope you can pass the appreciation forward. Before these parks were adapted for wheel chair access, I still bought my kids to the park to play. However, I also had to bring someone else with me that could watch and play on the equipment with them because my wheelchair could not maneuver through the wood chips. Now not only can I bring my boys to the park by myself, I can also safely play with them on the equipment. Thank you for making such a difference in my life.
