5. Describe the premises at which the event will take place (attach diagram).

The event is held in Lincoln Park, wouth of the Lincoln Park Barn and west of the Lincoln Park Pool. A map is also included in the application.

What type of and how many security will be provided?
Parks and Recreation staff (18-24 depending on time) and hired Citadel Security Officers (5 officers).

7. Describe the Security Control Plan (use additional sheet if necessary).

The beer area will be completely fenced with 4 entrances. At each entrance a Citadel Security Officer or Parks and Receation staff will be stationed at all times. All of the other hired Citadel staff will be inside of the beer area looking for over serving and monitoring the participants. All individuals will be ID checked wristbanded in order to drink any alcohol.

8. How will security personnel be identified?

All security will have on a Citadel staff uniform and City staff will also be wearing City of Grand Junction logoed uniform.

9. If this event is an outdoor event, how will the exterior boundaries of the premises be marked (i.e., roped, fenced, etc.)?

Portable fencing provided by FCI. Gates will be staffed by event personnel and security personnel.

Signs will also be posted for control of alcohol limits.

10. What method of age verification will be used (i.e., at the door, at the bar, etc.) and how will underage patrons be identified so as not to be served alcohol beverages (i.e., stamp or mark on the hand, etc.)?

Drivers license or other acceptable photo ID will be required and checked by trained staff. Wristbands will be used to verify that patrons have been checked and are able to be served.

11. How will the conduct and level of intoxication of attendees be monitored and by whom?

City and security staff will be monitoring behavior and watching for signs and symptoms as they have been trained.

12. Have the volunteers or members of your organization been trained in the sale/service of alcohol beverages?

Yes, they have been certified by the State of Colorado.

Mac & Cheese contest, concessions type food, soft drinks and water
