NEW BUSINESS

Budget: The art budget was reduced by 30% and the Champion of the Arts is postponed until 2021.

REPORTS

Redlands Roundabout: Donna and Matt J. updated us on the Redlands Roundabout project. 13 submission were received and 4 were short listed: Bobbie Carlyle, Gary Hauschulz, Pavia Justinian, and Jeff Bates. Proposals will go to the Parks Department for their budgetary inclusion and then presented to the public once it is safe to meet.

GVOST: Ron updated on the Grand Valley Open Studios Tour. 22 artists have been accepted into the 2020 tour. 2 artists have dropped due to COVID concerns. The committee will meet to discuss the status of the tour soon.

D51: John updated us on the elementary art funding. They are currently accepting applications for art education nest year. 18 schools applied for \$1000 each. \$16,000 is available.
