- The City is ordering trees for the 100th anniversary celebration of the Rotary Club. Attempting to purchase trees from J Frank Schmidt. Trees will be planted at Canyon View Park. The area around the trees will include a naturalized area. Current sprinkler zones should be adequate for trees. The area will have a heavily forested appearance.
- Pomona/Kronkight Looking at establishing a garden near the pump house. Looking at plating pollinator focused items. Susan may be able to provide seed company names. Native seed blends are preferred. Fall may be the ideal time to plant.
