OLD BUSINESS

Art Grant Updates: Lorie gave an update as to the status of the grantees. 5 organizations have given back their full funding and 1 a partial refund. Most other organizations are moving forward with modifications approved by the Art Commission. Updated plans are needed from Music Spark and Chautauqua. A motion was made by Donna Fullerton: Organizations that do not fulfill their obligations cannot apply for funding for 1 year. Matt Jansen seconded the motion, and it was carried unanimously.

Cultural Plan: The Commission continues to refine the invite list for work groups on updating the 2022-2027 Cultural Plan. John Cooper has created a spread sheet that is viewable by affiliation. It was decided to remove the tax initiative under strategies for Creative Districts and Industries and keep the overall format the same.

Write On: Gary Ambrosier reported that Write On! will begin in February with an April 1 deadline. Kelly affirmed that the Mesa County Public Library will put it on their website. The theme will be, "What Did You Create During Your Time at Home?" Lorie will send Gary the old flier.
