A liquor license application permitting sales of malt, vinous and spirituous liquor in sealed containers not for consumption at place where sold, was filed with the Local Licensing Authority on December 24, 2020 and on April 7, 2021 a legal notice was published in the Daily Sentinel and a "Notice of Hearing" was posted on the property.

A survey was conducted to address the reasonable requirements of the neighborhood via mailers to 120 properties in the defined neighborhood by the City Clerk's Office due to COVID-19 restrictions. The neighborhood was defined by those addresses within a half mile radius from the applicant's location.
