1. Call to Order/Announcements

The meeting was called to order at 4:00 pm at City Hall.

2. Approval of Minutes

Jody Motz moved to approve the minutes of the July 7, 2020 meeting. The motion passed unanimously on a second by Troy Reynolds.

3. Discussion Items

Consider a request by Nick and Jolyn Nicksic for a Certificate of Appropriateness for a concrete slab patio in the front yard of the property located at 515 North 7th Street

Kristen gave a presentation of the item, noting that the original request to include fencing in the front yard had been withdrawn so the request was only for the patio. A question was raised by Troy Reynolds regarding an apparent change to a front window of the enclosed porch. The Board will continue to investigate the concern.

Jody Motz made a motion to approve the item. The motion passed unanimously on a second by Troy Reynolds. The Applicant was not present for the hearing but attended the meeting after the item had been considered.

4. Updates

The Board discussed the potential relocation of the Operation Foresight shade structure "mushroom" from Little Park Road to somewhere downtown. The Board identified potentially the north side of the 700 block of Main Street. Troy and Ron will continue to work on the feasibility and costs of the move and Kristen will follow up with Brandon Stam with the Downtown Development Authority.
