A Hotel & Restaurant liquor license application, permitting sales of malt, vinous and spirituous beverages for consumption where sold, was filed with the Local Licensing Authority on April 1, 2021.

A survey was conducted by the applicant to address the reasonable requirements of the neighborhood. The neighborhood was defined on the North by Hill Avenue, on the South by 3rd Avenue, on the East by North 11th Street and on the West by N Spruce Street and includes both sides of the streets as the outer boundaries.


Boundary Map/Defined Neighborhood Area

6. What type of and how many security will be provided at this event and how will they be identified? 6 hired Citadel security officers in uniform and 5 CMU athletics staff in staff shirts.
7. What is the Control Plan for security at this event? (Use additional sheet if necessary) The event will be held in an entirely fenced area with one area for entrance and one area for exit. A Citadel officer will be checking ID's and verifying 21+ age upon entry. Anyone under 21 will be marked on both hands. There will be only one enterance and exit that everyone will have to check in at. Trained servers will be the only ones serving alcohol. The guards at enterance and exit will also be ensuring that no alcohol enters or leaves the premise. Trained bartenders, volunteers and Citadel security will be monitoring interviousless all night.

8. How will security personnel be identified? Citadel security will be in uniform and CMU athletics staff will be in CMU polos.
9. If this event is being held outdoors, how will the exterior boundaries of the premises be marked (i.e., roped, fenced, etc.)?
All exterior boundaries will be fenced with portable fencing and snow fencing. Please see attached map

What method will be used in checking identification for proper age of attendees (i.e., at the bar, etc.) and how will underage patrons be identified so as not to be served alcohol beverages (i.e., stamp or mark on the hand, etc.) ID will be checked by Citadel officer upon entry. All attendees 21+ will be wrist banded. At the bar only
those with a wristband will be served. If the server questions age of attendee, or they are not wrist banded
they will send them back to ID check to be verified and wrist banded.
11. How will the conduct and level of intoxication of attendees be monitored and by whom? Intoxication and conduct will be monitored by all trained servers and 5 roaming Citadel security as well as
safe server trained CMU staff.
12. Have the volunteers or members of your organization been trained in the sale/service of alcohol beverages?
Yes, the bartenders have all been trained in sale and service of alcohol. Additionally we will have trained
CMU staff volunteers.
13. What types of alternate beverages and food/snacks will be available? There will be light snacks, sliders, popcorn, chips and pretzels available. Water and pop will also be
available all night.
