Artline -7^{th} St between Main and Struthers. Lorie applied for a grant to AARP to improve 1 block. Long term goal - entire length will be activated with interactive art installations.

Memorial Chair for Warren Barnes in breezeway – privately funded, city approved. Installation in late summer.

Food Bank Mural – no word from them. Considered dropped.

The planned workshop was moved to an online format, with 17 people attending.

What were the strengths of the event?

The art was of exceptional quality, and was well displayed in both the Art Center exhibit and online format. in response to the pandemic issues, the exhibit was moved to the online format to keep it visible.

What were the weaknesses of the event?

The Covid pandemic forced the closure of the Art Center midway through the show period, resulting in low in-person attendance.
