GRAND JUNCTION LIQUOR LICENSING AUTHORITY MINUTES May 19, 2021

I. Call to Order

The meeting was called to order at 2:00 p.m. Those present were Hearing Officer Sam D. Starritt, City Attorney John Shaver and Deputy City Clerk Selestina Sandoval.

II. License Renewal Applications

Leslie Wilson and General Manager Maria Rainsdon were present to answer questions regarding the applications. Hearing Officer Starritt verified with Ms. Sandoval the applications were complete and asked if anyone was present to speak against them. There was no one. He read a letter regarding the late filing into the record (attached) and found good cause for the late filing. The application was approved contingent upon the completed background check on the new registered manager.

Expanding the store from space A1 into suites B1, B2, C1, and C2

Member Alex Vat and Broker Associate for Hill & Homes Stacey Cook were present to answer questions about the application. Ms. Sandoval reported the application was in order and read the survey results into the record (attached). Courtney Laney was present to answer questions regarding how the survey was conducted.

Hearing Officer Starritt asked if anyone was present to speak against the application. There was no one. The application was approved.

1. Decoy Ranch Brewing, LLC dba Decoy Ranch Brewing, 664 North Avenue, Grand Junction, CO 81501, Brew Pub

Sole Member Sandra Weckerly and Attorney John Howe were present to answer questions regarding the application. Ms. Sandoval reported that the application is complete and Ms. Weckerly is working with review agencies on getting approvals for this premises. Mr. Howe explained that there is a small business loan involved in acquiring the building which requires a liquor license before approval. Upon reviewing the diagram, the applicant noted that the second floor diagram should be removed as that will no longer be built on the premises.

Auriell Duncan was present to answer questions regarding how the survey was conducted. City Attorney Shaver noted two areas that were lacking signatures. Ms. Duncan reported that she did not go to those areas. Hearing Officer Starritt asked that those areas be recanvased for signatures.

Hearing Officer Starritt asked if anyone was present to speak against the application. There was no one. He found the needs and desires of the neighborhood are not being met and approved the license contingent upon the following:

- Successful closing of the premises
- Issuance of a certification of occupancy
- Supplemental record of needs & desires survey fulfilling areas missed previously (south of White between 7th and 12th and area west of Sherwood)

The City Clerk's Office will prepare a resolution of findings for Hearing Officer Starritt's signature.

Regarding the late filing and need to change the manager for the liquor license for the Two Rivers Convention Center, due to the COVID 19 Pandemic and resulting capacity limits, our staff was furloughed and then laid off. The former Banquet Manager and current Manager of Record on the Liquor License was laid off and made the decision to retire in April. Due to slow return to business, and the lack of events per mass gathering restrictions, we were delayed in filing the necessary paperwork.

Historically the Banquet Manager has been the Manager of Record for this Liquor License, but we have not rehired for that position yet. Leslie Wilson, Sales and Marketing Manager, will be filling that role for the time being. The change of Manager paperwork has been filled out and the completed application can be expected to arrive as soon as it is processed.
