4. Q. How long does decontamination and surveying take at the DOE?  
A. The decontamination and surveying will take around 1 hour per truck.
5. Q. Is the waste in the clarifier meet the waste acceptance criteria?  
A. Yes.
6. Q. How long does the required training take?  
A. The GERT, Driver Briefing, RWP, vehicle survey/inspection etc. are required and will be done on-site and should only take 2-3 hours. The 2-day RW-II training that was stated as a requirement at the first pre-bid meeting was incorrect.
7. Q. Can we keep our loaded truck on City property if it's too late to take to GJDS?  
A. The City is okay with the vendor keeping the loaded truck parked overnight at City Shops if tarped.
8. The City and DOE will provide water to prevent dust from the RRM.

The original solicitation for the project noted above is amended as noted.
