GRANT OF MULTIPURPOSE EASEMENT

Magerko Real Estate, LLC, a Pennsylvania Limited Liability Company, ("Grantor"), whose address is 1019 Route 519, Eighty Four, PA 15330, for and in consideration of the sum of Seven Thousand Six Hundred Eighty-four 00/100 Dollars (\$7,684.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, has granted and conveyed, and by these presents does hereby grant and convey to the City of Grand Junction, a Colorado home rule municipality, ("Grantee"), whose address is 250 N. 5th Street, Grand Junction, CO 81501, a Perpetual Multipurpose Easement for the use and benefit of Grantee and for the use and benefit of the Public Utilities, as approved by Grantee, as a perpetual easement for City approved utilities including the installation, operation, maintenance and repair of said utilities and appurtenances which may include but are not limited to, electric lines, cable TV lines, natural gas pipelines, sanitary sewer lines, storm sewers, water lines, telephone lines, traffic control facilities, street lighting, landscaping, trees and grade structures, on, along, over, under, through and across the following described parcel of land, to wit:

A certain parcel of land lying in the Northeast Quarter (NE 1/4) of Section 36, Township 1 North, Range 2 West of the Ute Principal Meridian, being a portion of Lot 1, Eighty-Four Lumber Simple Subdivision, as same is recorded in Plat Book 20, Page 34, Public Records of Mesa County, Colorado and being more particularly described as follows:

COMMENCING at the Southeast Corner of said Lot 1, Eighty-Four Lumber Simple Subdivision and assuming the South line of said Lot 1 bears N 66°06'50" W and all other bearings contained herein are relative thereto; thence from said Point of Commencement, N 66°06'50" W along the South line of said Lot 1 a distance of 248.89 feet to the POINT OF BEGINNING; thence from said Point of Beginning, N 66°06'50" W along the South line of said Lot 1, a distance of 28.63 feet to a point being the beginning of a 302.56 foot radius curve, concave South, whose long chord bears N 69°44'41" E a distance of 22.56 feet; thence Easterly along the arc of said curve through a central angle of 04°16'23" a distance of 22.56 feet to a point being the beginning of a 286.51 foot radius curve, concave South, whose long chord bears N 86°05'37" E a distance of 138.93 feet; thence Easterly along the arc of said curve, through a central angle of 28°03'48" a distance of 140.33 feet; thence S 79°57'36" E a distance of 33.23 feet to a point being the beginning of a 340.00 foot radius curve, concave Northeast, whose long chord bears S 81°32'14" E a distance of 18.72 feet; thence Southeasterly along the arc of said curve, through a central angle of 03°09'17" a distance of 18.72 feet to a point on the East line of said Lot 1; thence S 19°25'33" E along the East line of said Lot 1, a distance of 22.16 feet to a point being the beginning of a 360.00 foot radius curve, concave Northeasterly, whose long chord bears N 82°19'09" W a distance of 29.64 feet; thence Northwesterly along the arc of said curve, through a central angle of 04°43'06" a distance of 29.65 feet; thence N 79°57'36" W a distance of 33.23 feet to a point being the beginning of a 266.51 foot radius curve, concave South, whose long chord bears S 86°05'37" W a distance of 129.24 feet; thence Westerly along the arc of said curve, through a central angle of 28°03'48" a distance of 130.54 feet to a point being the beginning of a 282.56 foot radius curve. concave South, whose long chord bears S 71°45'10" W a distance of 1.27 feet; thence Westerly along the arc of said curve, through a central angle of 00°15'24" a distance of 1.27 feet, more or less, to the Point of Beginning.
