A liquor license application permitting sales of malt and vinous beverages for consumption at place where sold, was filed with the Local Licensing Authority on September 1, 2021, and a "Notice of Hearing" was posted on the property on October 8, 2021.

A survey was conducted to address the reasonable requirements of the neighborhood. The neighborhood was defined on the north by Grand Ave, on the south by South Avenue, on the east by 9<sup>th</sup> Street and on the west by 4<sup>th</sup> Street. The results are as follows:
