A Lodging & Entertainment liquor license application permitting sales of malt, vinous and spirituous beverages for consumption at place where sold was filed with the Local Licensing Authority on December 28, 2021, and a "Notice of Hearing" was posted on the property on January 10, 2022 and in the Daily Sentinel on January 19, 2022.

A survey was conducted to address the reasonable requirements of the neighborhood by Liquor Pros. The neighborhood was defined on the north by Patterson Road, on the south by Highway 6, on the east by 25 Road and on the west by North 1st Street. The results are as follows:


