I. Call to Order

The meeting was called to order at 2:03 p.m. Those present were Hearing Officer Sam D. Starritt, City Attorney John Shaver and Deputy City Clerk Selestina Sandoval.

Museum staff & volunteers will have name tags on identifying themselves.

Indoor event. No reentry permitted.

The event is a 21+ event. There will be 2 staff members checking IDs and putting stamps on hands. 2 bar tenders will be checking for stamps before serving alcohol. No one under the age of 21 will be permitted. No one without a stamp on their hand will be served alcohol.


