with all its appurtenances, and warrant the title to the same, subject to taxes for the year 1974 payable in 1975 and subsequent taxes.

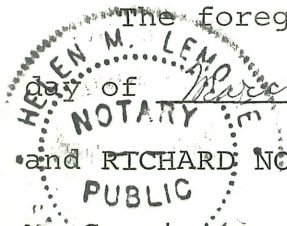
