

**GRAND JUNCTION LIQUOR LICENSING AUTHORITY**  
**MINUTES**  
**June 1, 2022**

**I. Call to Order**

The meeting was called to order at 2:00 p.m. Those present were Hearing Officer Sam D. Starritt, City Attorney John Shaver and Deputy City Clerk Janet Harrell.

**II. License Renewal Applications**

2. Brightstar Golf Redlands Mesa, LLC dba The Golf Club at Redlands Mesa, 2325 W Ridges Blvd, Grand Junction, CO 81507, Hotel & Restaurant/Optional Premises x5
3. J & K Enterprises, Inc. dba Citrola's, 759 Horizon Drive, Units M, N, and O, Grand Junction, CO 81506, Hotel & Restaurant

Safeway Stores 46, Inc. submitted Modification of Premises applications to increase the alcohol shelving for Safeway Store #2625 (681 Horizon Drive, Grand Junction, CO 81506) and Safeway Store #1533 (2901 Patterson Road, Grand Junction, CO 81504) and requested the survey requirement be waived as the additional shelving would be a minimal change and would not affect the licensed premises footprint. Hearing Office Starritt approved the request.
