River Corridor Initiative

We've been moving ahead with some things:

1. Formed and met with a Gov't Advisory committee of local and fed agencies
2. Engaged with the Dos Rios Developer to discuss the beach and connection to the island (I can share details, we'll want to comment from ORF regarding how the trail fits in to all of this and we'll have an opportunity to comment over the next couple of weeks).
3. Kicked off the Fluvial Geomorphic Mapping project for the Grand Valley
4. Will be participating in a GOCO/CPW Regional Partnership Initiative planning effort this year for coordinating conservation and recreation in the Grand Valley river corridor (in conjunction with the Outdoor Rec Coalition).
5. Gearing up to apply for a CWCB Stream Management Plan grant in November in partnership with the County.
