The City of Grand Junction's 2022 Adopted Budget, totaling \$237 million, reflects the City Council's key priorities in the areas of Housing, Mobility and Infrastructure, Public Safety, Quality of Life, and Economic Development. The City has begun embarking on several steps to address housing and homelessness issues in the community, including the development of a Housing Needs Assessment, and a Housing Strategy adopted by the City Council. Increasing environmental pressures such as drought and fire potential in our region have also highlighted the importance of creating a citywide Sustainability Plan. The City continues to identify opportunities for improved transit, trail, and mobility options, including the creation of a Pedestrian and Bike Plan and support for the development of a downtown mobility hub utilizing grant funding secured by the Colorado Department of Transportation. Additionally, there is an added focus on increased community engagement through our public engagement platform, GJSpeaks.org, and improved access to translation and interpretation services. Funding is also planned to improve fire and police service through expanded parks patrol, improvements to the Co-Responder program and continued capital and equipment investments to support fire and EMS services.

Grand Junction was recently highlighted by Red Bull in a five-page feature article in their September 2022 newsletter noting GJ as a hidden gem. Additionally, the City is proud to have been named one of Kiplinger's Best Places to Retire in 2022, which was based upon having access to high-quality health care, abundant activities, and a lively downtown.

As a resident and passionate ambassador of our community, I am proud of how the awe-inspiring natural beauty of our valley makes Grand Junction an amazing place for anyone to live as well as visit. The photography in this year's calendar serves to remind me just how grateful I am to live in such a stunning area.

On behalf of your City Council, I wish you joy and fulfilment in 2023, and hope you join me in celebrating the New Year with appreciation for this beautiful place we are so fortunate to call home.







### How the Revenues are Spent by Department




### How the Revenues are Spent by Category

#### **Budget by Strategic Priority**




# **Sales Tax Revenue by Industry**
