Subject: Sole Source Justification for Knox Mini Med Vault System

In an effort to make all of our apparatus compliant with DEA narcotic storage and tracking policies, the department would like to purchase 18 Knox Mini-Med Vaults via a Sole Source.

The department purchased electronic safes from Narctrak in 2019. These safes have had multiple system failures which have resulted in temporarily missing narcotics and narcotics being locked in a safe for extended periods with no ability to access them.

In March of 2022, the department researched available options that would meet our goal of DEA compliance. After this research, we solicited two vendors for a trial of the available narcotic storage safes and compared them to our current Narctrak model. Safes were received from Knox Mini Med Vault, and Medixsafe. Multiple aspects of the safes were evaluated and are listed below:

- -Complexity of Use
- -Availability of Manual Backup
- -Potential for technology failure
- -Build Quality

The overwhelming winner of the trial was the Knox Mini Med vault. This unit received 100% of the recommendations and scored almost perfectly in all evaluated categories. The results of this evaluation are attached to this justification.

We have already started purchasing individual safes to place in our new ambulances. This purchase would create conformity of the units on every apparatus on the department.

Due to the trial results and the fact that this would create conformity with all department units, we would like to move forward with a Sole Source with Knox for their Mini-Med Vault product.
