**Re: Sole Source Narrative for Kustom Signals Radar Raptor RP-1**

I have had the responsibility of managing the police radar speed measurement tools for the GJPD for many years now. Over the years, after using, installing and maintaining several different models from several different manufacturers, I have determined the Kustom Signals Raptor RP-1 to be the preferred make and model of radar speed measurement tool for our department.

The average life span for a speed measurement radar tool is 7-8 years. This has been typical for the Golden Eagle speed radar measurement tools that our department has been migrating away from for several years now. Since switching from the Golden Eagle to the Raptor RP-1 model, I have not yet had to send one unit back for repair even though some of the units on several of our marked vehicles have units older than 7-8 years in them.

In taking into consideration the service life of our current Raptor RP-1 units on our fleet of BMW Traffic Unit motorcycles with their near constant exposure to the elements of weather, none of these units have needed any repair which necessitated their return to the manufacturer.

Furthermore, I believe it is in the best interest of this department to stay with the Kustom Signals Raptor RP-1 for our patrol fleet of vehicles which includes our motorcycles. The majority of our patrol vehicles now have the Kustom Signals Raptor RP-1 installed in them, which makes for consistency throughout our fleet. Additionally, all officers are currently trained on the use of the Kustom Signals Raptor RP-1 radar and if we changed to another make or model we would have to retrain officers in that, this way the training is consistent. The ease of use and accuracy in speed measurement is vital for our efforts in traffic enforcement as well as presenting in court cases regarding our radar speed measurements.
