ORDINANCE NO. 5138

AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF GRAND JUNCTION, COLORADO CLEAR CREEK ENCLAVE ANNEXATION

LOCATED IN THE BROOKDALE SUBDIVISION: A REPLAT OF BROOKDALE (BOOK 13, PAGE 47) INCLUDING 3141 THROUGH 3147 CRIPPLE CREEK COURT AND 3141 THROUGH 3147 CASCADE CREEK COURT APPROXIMATELY 3.86 ACRES

WHEREAS, on the 1st day of March 2023, the City Council of the City of Grand Junction considered a notice of Intent to annex for the annexation of the following described territory to the City of Grand Junction; and

WHEREAS, a hearing was duly held after proper notice on the 5th day of April, 2023; and

WHEREAS, the City Council determined that said territory was eligible for annexation and that no election was necessary to determine whether such territory should be annexed;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF GRAND JUNCTION, COLORADO:

That the property situate in Mesa County, Colorado, and described to wit:

A parcel of land being a portion of Brookdale: A Replat of Brookdale (book 13, page 47) subdivision same as recorded at Reception Number 1365595 located in the Northeast Quarter of the Southwest Quarter (NE1/4 SW1/4) of Section 15, Township 1 South, Range 1 East, Ute Meridian, Mesa County, Colorado more particularly described as follows:

Commencing at the Center Quarter Corner of said Section 15, whence the Center West Sixteenth Corner of said Section 15 bears N89°54'30"W a distance of 1,310.18 feet using the Mesa County Local Coordinate System with all other bearings contained herein being relative thereto; thence along the North line of said Northeast Quarter of the Southwest Quarter, N89°54'30"W a distance of 165.08 feet to a point on the west line of the CABALLERO ANNEXATION, ORDINANCE NO. 4763; thence along said west line of the annexation S00°04'40"E a distance of 33.00 feet to the Point of Beginning; thence continuing along said west line S00°04'40"E a distance of 504.02 feet to the Northeast Corner of the INGLE ANNEXATION, ORDINANCE NO. 4149; thence along the north line of said annexation the following three (3) courses, 1) S89°55'20"W

a distance of 274.98 feet, 2) S00°04'40"E a distance of 23.00 feet, 3) S89°55'20"W a distance of 55.00 to a point on the east line of the MESA AYR ANNEXATION, ORDINANCE NO. 4170; thence along said east line of the annexation N00°08'58W a distance of 528.00 feet to a point on the southerly line of the SUMMIT VIEW MEADOWS ANNEXATION NO. 3, ORDINANCE NO. 3460; thence along said southerly line of the annexation S89°54'30"E a distance of 330.64 feet to the Point of Beginning (Property).

Said Property CONTAINING 167,918 square feet or 3.86 acres, more or less, as described herein and as shown on Exhibit A to this Ordinance is duly and lawfully annexed to the City of Grand Junction, Colorado.

ADOPTED on second reading the 5th day of April 2023 and ordered published in pamphlet form.


