SUBJECT: Sole Source Elgin Broom Bear Street Sweeper

The Fleet services division is requesting sole source approval for the purchase of Elgin Broom Bear mechanical street sweepers. These units are designed with a single engine that powers both the vehicle chassis and the sweeping unit and is powered by the Biogas produced at the Persigo wastewater treatment facility.

The city's storm water division operated three street sweepers which are replaced every 6 years. The purchase/ replacement cycle for each unit is staggered by one year per machine. In 2022 the city purchasing division solicited a request for proposal for the 1st of three replacements and the Elgin unit was chosen due to historic maintenance history and cost, reliability, access to parts and local Colorado representation for warranty service and support. Due to unknown inflation, Elgin could not agree to an additional 2-unit price hold at that time. The attached quote represents a 5.5% increase over the 2022 awarded price which is inline with a normal inflation rate expected on large equipment.

Maintaining a consistent reliable fleet is beneficial to both operators, and maintenance personnel. It allows for familiarity of operation across all assigned operators, meaning if an operator is required to use a different unit, it will function identical to all other units. Diagnosis and repair will be repetitive to fleet staff eliminating the need to determine different mechanical systems, less spare common use parts will be required as all units will share components, and preventive maintenance tasks will be identical which will make repairs more efficient.

This purchase is planned as part of Fleets 2023 adopted replacement budget and was approved by the replacement committee. with a third purchase anticipated in 2024.

Purchase of CNG Powered Elgin Street Sweeper

RECOMMENDATION:

Staff recommends a sole source approval for the purchase of a CNG powered Elgin Broom Bear street sweepers from Joe Johnson Equipment company in the amount of \$417,854, in 2023

EXECUTIVE SUMMARY:

The Fleet Services division is requesting a sole-source purchase of a Elgin street sweeper. This machine is a replacement of a sweeper that is at the end of life and is scheduled to be replaced.

BACKGROUND OR DETAILED INFORMATION:

The city's Storm Water division operates three full-sized street sweepers which are replaced every 6 years. A smaller bike lane sweeper has been budgeted for 2023 and will be procured later this spring. The purchase/replacement cycle for each of the full-sized units is staggered by one year per machine. In 2022, the City Purchasing division solicited a request for proposal for the first of three replacements and the Elgin unit was chosen based on historical maintenance history, cost, reliability, access to parts and local Colorado representation for warranty service and support. Maintaining a consistent, standardized, reliable fleet is beneficial to both operators and maintenance personnel. It allows for familiarity of operations with all assigned operators. Diagnosis and repair will be repetitive for fleet staff, eliminating the need to determine different mechanical systems and fewer spare parts will be inventoried as all units will share components.

Per Section 10.10 of the Purchasing Manual, all solicitation documents shall remain

confidential until the Purchasing Division awards the contract.

FISCAL IMPACT:

This purchase is included as part of the 2023 adopted budget.

I move to approve the City Purchasing Division to enter a contract with Joe Johnson Equipment Company for the sole source purchase of an Elgin Broom Bear street sweeper, in the amount of \$417,854.
