Minutes

Call to Order/Announcements

Diana R. called the meeting to order at 5:35 pm.

Diana R. reviewed the annual roadmap and informed the group to start thinking about the Ped and Bike Count in May, reigniting the subcommittee for ped/bike counts.

Diana R. reminded the group about the January workshop. Dani A. to create a virtual option.

Trent recommended leaving SRTS open to suggestions for CBDG candidates - Pull that together in February.

The UTC reviewed the November and December minutes and voted on approval. Athena F. made a motion to approve the November meeting minutes, and Brent S. seconded the motion. The motion passed unanimously. Athena F. made motion to approve the December meeting minutes and Ian T. seconded the motion. The motion passed unanimously.

A question was posed if quorum was based on the total number of members as outlined in the bylaws or by the number of existing members (i.e., even with vacancies). Dani A. to check with City Attorney about quorum.

Action Items

The UTC reviewed and voted on the 2022 Annual Report. Mike H. made a motion to accept the draft and Steve M. seconded the motion. The motion passed unanimously.

Zoning & Development Code Updates

Dani A. informed the group that Module 2 on Parking Standards for the ZDC update was now available, which including parking standards for bikes. The group discussed the proposed changes.

The group discussed the need to revise site upgrade standards for long-term bike parking for Change of Use (COU) multifamily projects (motels converting into residential apartments).

Ian T. suggested reducing parking in exchange for a long-term sufficient bike storage.

Jason N. suggested the ZDC update specify a list of approved and disapproved bike rack designs.

Ian T. commented that the rings in the Post & Rick rack design on the Main Street are way thicker than the ring. Suggested that the ZDC specify that rings be of a certain diameter. If rings are placed lower, you can get pedal on it.
