Offerors responding to the above referenced solicitation are hereby instructed the requirements have been clarified, modified, superseded, and supplemented as to this date as hereinafter described.

Please make note of the following clarifications:

1. The following sections have been modified/updated as follows:

- 1.1. Purpose:** The City of Grand Junction is soliciting competitive bids from qualified and interested Vendors to provide an estimated two (2) year supply of Pet Waste Header Bags (512 cases with 2,000 bags per case and 100 bags per header). The City also requires an estimated seventy-five replacement bag dispenser stations.

- 3.1. General:** The City of Grand Junction is soliciting competitive bids from qualified and interested Vendors to provide an estimated two (2) year supply of Pet Waste Header Bags (512 cases with 2,000 bags per case and 100 bags per header). The City also requires an estimated seventy-five replacement dispenser stations. Delivery cost of the products to the City of Grand Junction will be included in the quote price.

- 3.1.1. Header Bag Dispenser Station:** The Owner currently uses the Pet Pick-Ups © brand Nature Dog dispensers, which are nearing its end of lifecycle. The City requires the Vendor supply seventy-five (75) replacement header bag, key-locking dispensers with mounting hardware.

Dispensers will be commercial grade, locking, low maintenance, long lasting material, and resistant to vandalism. Vendor must provide product specification sheet, which should provide brand, manufacturer part number/SKU, material, dimensions, header/wicket capacity, bag size, and warranty information.

Vendor must provide its policy for dispensers to include: replacement and return for defective and/or vandalized dispensers.

2. Vendors shall utilize the Addendum 2 version of the Price Bid Schedule attached for its bid response.

The original solicitation for the project noted above is amended as noted.

All other conditions of subject remain the same.
