At the City of Grand Junction, we recognize that purchasing a home can be a major challenge – especially when it comes to saving for a down payment and covering closing costs. Every bit of support can make a difference, and we're here to help.

Through the Employer-Assisted Homeownership benefit, the City is proud to support our employees in achieving their goal of homeownership. This initiative helps make homeownership more accessible by reducing financial barriers and accelerating the path to owning a home!

Program Eligibility

Participation in the program may start anytime. To qualify for the City's \$1,000 forgivable down payment match, you must meet the following requirements:

- Be a full-time, benefits-eligible employee of the City of Grand Junction.
- You are not a current homeowner and have not owned a home within the past three (3) years.
- Have a combined gross household income at or below 150% of the Mesa County Area Median Income (HRWCO can provide current figures).
- Complete the Partners in Homeownership Application and be assessed for eligibility through HRWCO.
- Submit your Certificate of Eligibility from HRWCO to the City's Benefits Department.
- Receive counseling, if needed, from a Housing Authority-approved counselor regarding the down payment assistance and loan program selection.
- Successfully complete the Home Buyers Education class. (This class is available free inperson or online for a fee.)

Steps to Access Employer-Assisted Homeownership Program Funds

Offered by the City of Grand Junction & Housing Resources of Western Colorado (HRWCO)

All steps must be completed to qualify for assistance.

- 1. Complete the Homebuyers Education Class. Classes are offered monthly and are free of charge, register online at www.hrwco.org or call (970) 241-2871.
- 2. Find and select your new home!
- 3. Complete Partners in Homeownership Application.
- 4. Submit the following documents & required documentation to Jason Colunga of Housing Resources of Western CO (jasonc@hrwco.org) & City of GJ Benefits Department (benefits@gjcity.org).
 - Completed Partners in Homeownership Application
 - City of Grand Junction Employee Verification Form
 - Copy of your Homebuyers Education Certificate
 - Copies of your last 30 days of paystubs
- 5. Once all documents are received & reviewed, HRWCO will send a 'Letter of Verification' to both the employee and employer.
- 6. Request a letter from your mortgage lending containing the following details and email it to benefits@gjcity.org at least 2 weeks prior to closing!
 - Confirmation that you are contributing at least \$1,000 of your own funds toward the home purchase
 - Date and time of closing
 - Title company name
 - Name of the financial institution receiving the down payment wire transfer
 - The financial institution's ABA/Routing Number, Account Number & Reference Number (if applicable)
- 7. The City of Grand Junction's Finance Department will initiate the \$1,000 wire transfer to the designated financial institution on the day of closing or preceding business day.
