**I. Call to Order**

The meeting was called to order at 2:03 p.m. Those present were Hearing Officer Sam D. Starritt (via phone), City Attorney John Shaver, and Deputy City Clerk Janet Harrell.

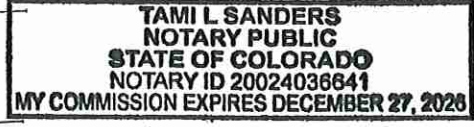

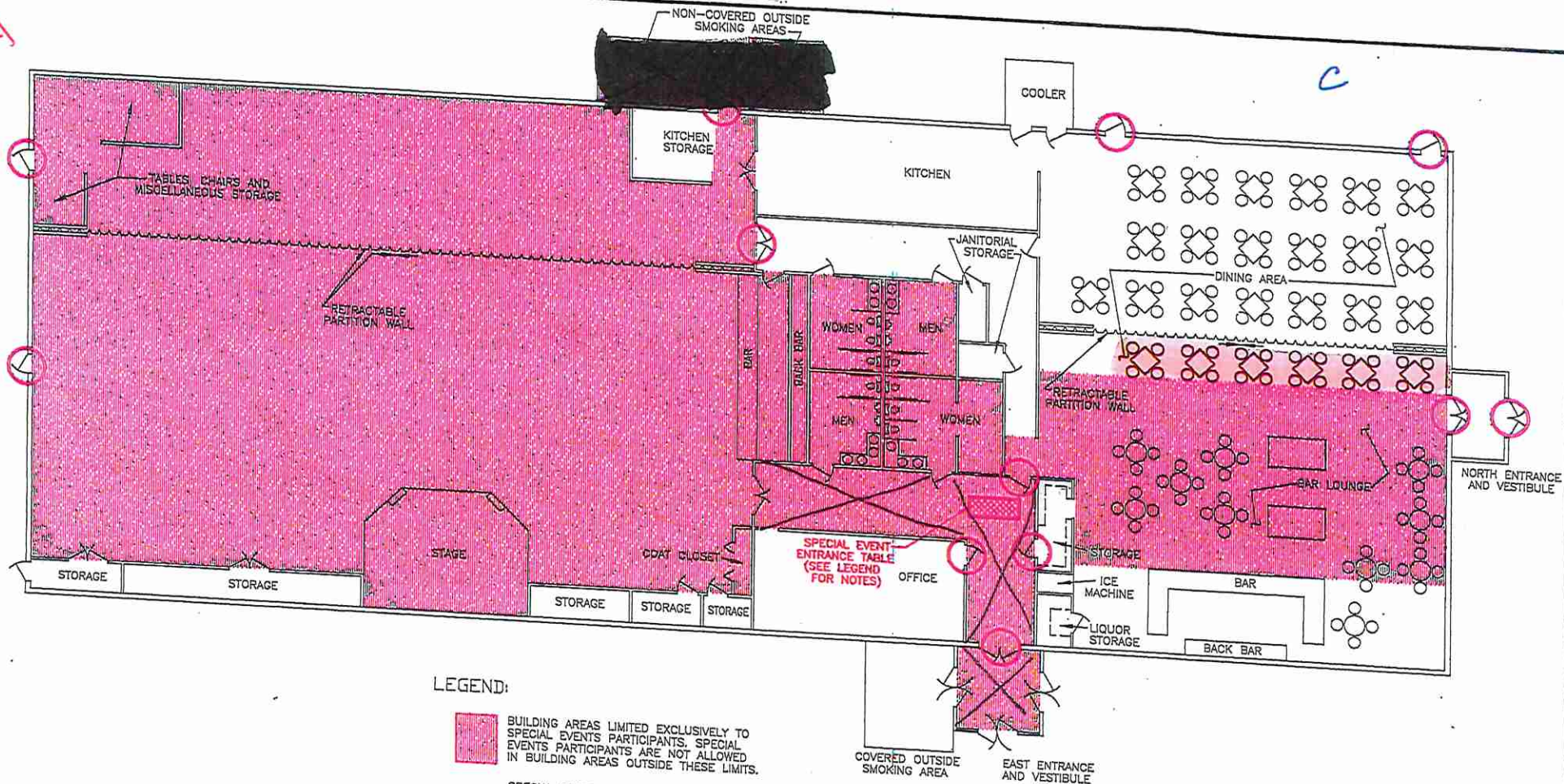

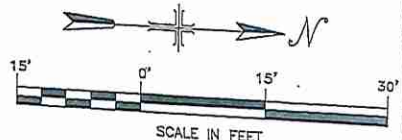
