**ACI Concrete and Flatwork Finisher and Technician:** Hand finishing concrete will be permitted only when performed under the direct supervision of a craftsman holding the following certificate: ACI Concrete Flatwork Finisher and Technician (ACICFFT) or other Flatwork Finisher certification program approved by the City Engineering Manager.

Craftsman certificate verification will be required at time of bid opening. Contractor to provide information in section 4.0 of this solicitation.

2. Contractors shall use 4.0 Contractor's Bid Form (Addendum 2) version attached for bid submittal.

The original solicitation for the project noted above is amended as noted.

All other conditions of subject remain the same.
