Offerors responding to the above referenced solicitation are hereby instructed that the requirements have been clarified, modified, superseded and supplemented as to this date as hereinafter described.

Please make note of the following clarifications:

1. **Q:** There's still some uncertainty with the addendum.
For Lines 3 and 4 you state that you are looking for a 40' container One tripper (Cargo worthy) (High Cube or Standard) - A one trip container is used one time, mostly from China to the United States. A cargo worthy container can be over 20 years old and be rusty and battered and really ugly but is still able to be used to transport goods all around the world. So I'm not clear on what exactly you are looking for. Can you please help me clarify?

A: Please review addendum two version of price bid schedule for answer.

2. Specifications have been modified to the following and bid alternates have been added.

Specifications: The City is requesting the following:

- Four (4) 40' High Cube Storage Containers (One Trip or Multi Trip) (If Multi Trip, Cargo Worthy.)
- Two (2) 20' High Cube Storage Container One Tripper (Well Sealed)
- One (1) 40' High Cube Storage Container One Tripper (Well Sealed)

Bid Alternates:

- One (1) 20' Standard Storage Container One Tripper (Well Sealed)
- One (1) 40' Standard Storage Container One Tripper (Well Sealed)

3. Firm shall utilize the addendum 2 version of the price bid schedule attached for their bid.
4. Section 3.5 IFB Tentative Time Schedule shall be modified as follows:
