RESOLUTION NO. 2023 -1

A RESOLUTION CONTINUING INACTIVE STATUS FOR THE MOSAIC METROPOLITAN DISTRICT #1

WHEREAS, the Mosaic Metropolitan District #1 in the County of Mesa, State of Colorado, is a Colorado Special District duly organized and existing under the provisions of Title 32, Colorado Revised Statutes, and pursuant to that certain order entered by the District Court in and for the County of Mesa and recorded on November 29, 2018, at Reception No. 2862835 of the official records of the Mesa County Clerk and Recorder; and

WHEREAS, on December 8, 2023, the Board of Directors determined that it was in the best interests of the District and its inhabitants to continue status as an inactive district pursuant to Section 32-1-104(3), C.R.S. and that such Notice of Inactive Status be filed with the appropriate agencies;

WHEREAS, Larry B. Beckner, being the only member of the Board of Directors and only eligible elector holding an interest in property within the District, has waived notice of the special meeting held on December 8, 2023; and

WHEREAS at a special meeting of the board held on December 8, 2023, the board considered continuing the inactive status of the District and the board determined that to do so was in the best interests of its electors and of the District.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF DIRECTORS OF THE MOSAIC METROPOLITAN DISTRICT #1:

- 1. <u>Inactive Status.</u> The Board hereby elects to continue to be governed by the provisions of Section 32-1-104(3) and to remain on Inactive Status.
- 2. <u>Filing of Notice</u>. A copy of the Notice of Continuation of Inactive Status shall be electronically filed with the Division of Local Government and a copy shall be filed with the Mesa County Board of County Commissioners, with the City of Grand Junction, the Mesa County Treasurer, Assessor and Clerk and Recorder, the Mesa County District Court, and the Office of the State Auditor.
- 3. <u>Effective Date.</u> The above notices shall be filed with an effective date of December 8, 2023.
