V. REVIEW AND AUTHORIZE STIPULATION, AGREEMENT AND ORDER

1. Mimosa Inc. dba Fairgrounds Wine and Liquor, 2771 B ½ Road, Grand Junction, CO 81503, Retail Liquor Store

Pursuant to Colorado Revised Statutes §12-47-901(1)(h)(I), it is unlawful to consume malt, vinous, or spirituous liquor in any public place except on a license premised permitted under this article to sell such liquor by the drink for consumption thereon.

Pursuant to Colorado Revised Statutes §12-47-407, it is unlawful to consume malt, vinous, or spirituous liquors at place where sold.

Pursuant to Regulation 47-900 of the State of Colorado Liquor and Beer Code of Regulations, it is unlawful for any employee or agent of such licensee to permit on the licensed premises loitering of a visibly intoxicated person.

It is alleged that on May 14, 2013, the Licensee, by and through its local President/Treasurer/Manager, Jery Sparks, consumed Smirnoff Kissed Caramel flavored Vodka shooters (50 ml bottles), Bud Light beer, and shooters of Fireballs (cinnamon liqueur) at the licensed premises and permitted himself to be visibly intoxicated on the licensed premises.
