A liquor license application for a Lodging & Entertainment license permitting sales of malt, vinous and spirituous liquor for consumption at place where sold, was filed with the Local Licensing Authority on February 1, 2024, and on February 21, 2024, a legal notice was published in the Daily Sentinel and a "Notice of Hearing" was posted on the property.

A survey was conducted to address the reasonable requirements of the neighborhood. The neighborhood was defined as the area bounded by Ouray Avenue on the north, South Avenue on the south, North 6th Street on the east and Park Avenue on the west and includes both sides of the outer boundary streets. The City Clerk's Office reviewed the findings and obtained the following results (map attached).

Business Results:

FAVOR: 54 OPPOSE: 0 Residential Results:

FAVOR: 21 OPPOSE: 0

Four signatures were disqualified due to being out of area and seven for incomplete entries. To date, no counter petitions or remonstrances have been filed. Exhibits to survey sheets showed 37 addresses attempted with no answer.

The Grand Junction Police Department will investigate the individuals for local criminal history. Reports have also been requested from Mesa County Public Health, the Grand Junction Fire Department, and the City of Grand Junction Sales Tax Department.




