

We have experience volunteers, new volunteers will be given a thorough training in advance of the event. I will conduct the training using 13 years of bartending experience following industry standard principles.

We will have a foodtruck within the rope boundary on premises.

The event will be held in Lincoln Park in the grass area south of the Barn and west of the pool. It is called the "Loop".

Citadel Security officers (4)

Parks and Recreation Staff (at least 6)

The perimeter will be fenced with t-posts and snow fence. There will be three entrances/exits. A security officer will be stationed at each entrance. The fourth officer will roam. Parks and Recreation staff will be throughout the area during the entire festival. All officers and staff will be looking for over-serving and monitoring the behavior of the participants.

8. How will security personnel be identified?

All security personnel will have on a Citadel staff uniform. Parks and Recreation staff will be indentified by a logoed shirt, jacket, and/or hat.

9. If this event is an outdoor event, how will the exterior boundaries of the premises be marked (i.e., roped, fenced, etc.)?

The perimeter will be fenced with t-posts and snow fence.

10. What method of age verification will be used (i.e., at the door, at the bar, etc.) and how will underage patrons be identified so as not to be served alcohol beverages (i.e., stamp or mark on the hand, etc.)?

There will be one station at the north entrance where staff will check IDs, wristband those that are 21 years of age and older, and sell the tasting mugs. Alcohol vendors will only serve to those that are wristbanded and have a mug.

11. How will the conduct and level of intoxication of attendees be monitored and by whom?

Grand Junction Parks and Recreation, Citadel Security staff, and the beer vendors will monitor behavior

and watch for signs and symptoms of intoxication in accordance with their training.

12. Have the volunteers or members of your organization been trained in the sale/service of alcohol beverages?

Yes, more than half have attended S.M.A.R.T. (Servers & Managers Alcohol Responsibility Training)



| second gated area, which enters onto the front lawn 2.) ID check and banding area 3.) at the front stage |
| All possible issues observed will be brought to the attention of the event coordinator and dealt with |

| Paid security personnel will be dressed in their Citadel uniforms and the volunteer staff will wear clearly |
| visible badges labeled "Security". |

9. If this event is an outdoor event, how will the exterior boundaries of the premises be marked (i.e., roped, fenced, etc.)?

There is a permanent six foot high steel fence surrounding the entire area of the botanical gardens. There

is only one entrance and exit that will be opened to the public during the event, which is located at the east end of the botancial gardens area.

10. What method of age verification will be used (i.e., at the door, at the bar, etc.) and how will underage patrons be identified so as not to be served alcohol beverages (i.e., stamp or mark on the hand, etc.)?

ID checks will be made by the TIPS trained volunteer staff as patrons enter through a second gated area onto the front lawn. Wrist bands will identify who is 21 years of age or older for events that allow all ages.

Bands will be applied after ID check is verified. Ticket sales and servers will verify bands prior to serving.

11. How will the conduct and level of intoxication of attendees be monitored and by whom? All events will have paid security staff monitoring conduct and level of intoxication.

TIPS trained staff, volunteers and bartenders will monitor level of intoxication prior to serving attendees.

12. Have the volunteers or members of your organization been trained in the sale/service of alcohol beverages?

Yes, we will have TIPS trained staff. Tulips & Juleps will have fully trained, paid bartenders. TIPS

training information will also be provided for first-time volunteers prior to events.

13. What other types of beverages and food/snacks will be available?

Water and soda, in addition to a food truck on the premises - certified by both the city and county.

Tulips & Juleps will be catered by Cowboy & the Rose.


