Patrick Maroney of Alcohol Petitioning Services appeared by phone & answered questions regarding how the needs and desires survey was conducted. Hearing Officer Starritt asked Ms. Williams to read the survey results into the record (attached).

Hearing Officer Starritt verified with Ms. Williams the application was in order. Ms. Williams reported that background results for Chengle Li, Member of Surf to Turf INC had not been received. Hearing Officer Starritt asked if anyone was present to speak against the application. There was no one.


