Call to Order/Announcements: Meeting called to order at 5:31 Henry introduced Owen to the Committee.

Meeting Minutes

1. June Minutes

Subject: Letter of Support – More Housing Now and Land Use Initiative

On behalf of Grand Junction's Urban Trails Committee, we are pleased to express our support for the City in their application to the Colorado Department of Local Affairs for funding to support the development of Complete Streets infrastructure at the Salt Flats site. As an advisory committee to City Council, the Urban Trails Committee is tasked with providing guidance to elected officials and City Staff on programming, policy, and physical infrastructure to ensure our entire community has access to safe, comfortable, and right-sized transportation options to meet their daily needs.

In some households in Grand Junction, transportation costs can approach or even exceed housing costs. Walking, bicycling, and transit are significantly more affordable than owning and operating a private motor vehicle, so it is critical for projects like the Salt Flats to create opportunities to safe conveyance for future residents of 350-550 affordable and attainable housing units. Proposed designs for sidewalks and cycle facilities which exceed the minimum standards, appropriate for those of all ages, abilities, and incomes to travel with dignity will demonstrate Grand Junction's commitment to meaningfully addressing the housing shortage.

Grand Junction is a vibrant, small, but quickly growing community. The Urban Trails Committee supports managing the impact of that growth by creating options for all residents and visitors to right-size their travel modes. With continued support from the Colorado Department of Local Affairs and the More Housing Now and Land Use Initiative, the City will maximize the development of safe and connected infrastructure, creating a welcoming environment and helping reduce cost burdens for our most vulnerable residents.

Subject: Letter of Support – Safe Streets and Roads for All Grant Program

14 August 2024

On behalf of Grand Junction's Urban Trails Committee, we are pleased to express our support for the Grand Valley Regional Transportation Planning Office (RTPO) in their application to the U.S. Department of Transportation for funding for demonstration of Safe Streets and Roads for All projects.

As an advisory committee to City Council, the Urban Trails Committee is tasked with providing guidance to elected officials and City Staff on programming, policy, and physical infrastructure to ensure our entire community has access to safe, comfortable, and right-sized transportation options to meet their daily needs. The work Mesa County, the City of Grand Junction, and the RTPO have already put into compiling and analyzing data to support the development of a Safety Action Plan has been inspiring, but many of the proposed mitigation strategies will be new to our remote community. The safety issues we face daily while traveling on public roadways are serious, and it is important to have begun to quantify and classify crashes, especially those which result in serious injury or fatality. This is the critical first step to creating systematic safety improvements to reduce the likelihood of crashes or their severity, when they do happen.

As a City with fairly compact geography, predominantly sunny weather, and flat topography, Grand Junction and the surrounding valley lend themselves well to walking, bicycling, and other active transportation modes. However, the risks of sharing space with speeding motor vehicles, especially those operated by impaired drivers create a high level of concern, and rightfully so. By evaluating the efficacy of treatments like speed-feedback signage, intersection hardening, and education campaigns, Mesa County and the RTPO will demonstrate that we can and will make a difference in the safety of our public infrastructure.

Grand Junction is a vibrant, small, but quickly growing community. As the community grows, new infrastructure is developed and existing infrastructure is updated, it will be critically important to know which safety strategies have the highest potential to reduce the likelihood and severity of crashes. The Urban Trails Committee supports managing the impact of that growth by ensuring all residents and visitors can travel safely to their destinations. With continued support from the U.S. Department of Transportation and the Safe Streets and Roads for All Grant Program, Mesa County and the RTPO will be more effective in maintaining a safe network of roadways.
