

AFFIDAVIT OF NOVA TUCKER

Nova Tucker, after first being sworn under oath, deposes and states:

- 1. My name is Nova Tucker. I am a resident of Mesa County, Colorado.
- 2. I was hired by Blitz Canvassing as an independent contractor to conduct a survey of the residents and business owners/lessors in the neighborhood that surrounds the new Asteria Theatre building located on the campus of Colorado Mesa University at 864 Bunting Avenue, Grand Junction, Colorado. The neighborhood was designated by the City of Grand Junction as bordered to the north by Orchard Avenue, to the south by Gunnison Avenue, to the east by 12th Street and to the west by 5th Street.
- 3. I have worked for more than five years for different companies to circulate petitions for ballot measures in Colorado. My work in this regard has been in Mesa County, Colorado. I have frequently worked for Blitz Canvassing on past projects.
- 4. I have attended annual on-line training classes put on by the Colorado Secretary of State's office concerning the appropriate methods and conduct to circulate ballot petitions. I reenroll in this training each year to keep up to date with the proper ways to circulate petitions and surveys within neighborhoods. The last class I attended was on February 4, 2024. I also now teach other people about circulating petitions. I also received specific instructions from Blitz Canvassing for the liquor license for the Asteria Theatre
- 5. I have read the Blitz Canvassing Petition/Survey Results Report, a copy of which is attached to this Affidavit. The Petition Methodology written on page 2 of that Report is accurate except that I approached houses with "no solicitor signs," as I was not soliciting for a product or service. The people at those locations were receptive to being part of the survey for a liquor license and participated in the survey.
 - 6. I was instructed by Blitz concerning the nature and type of liquor license applied for and the importance of explaining to people that the resident or business owner/lessee had the

opportunity to sign in favor of or sign as opposed to the issuance of the liquor license. At each house or business I approached, I explained that the resident had the option of being in favor or opposed, or not signing at all..

- 7. I circulated the surveys between July 8 and July 13, 2024. For the most part, I approached business entities during day business hours and residential neighborhoods during evening hours in an attempt to reach all the people that I could. I estimate that I knocked on more than 300 doors. More than half of the homes I knocked on were either not home or did not answer the door.
- 8. There were five people that were opposed to the license that did not sign a survey form as being opposed.
- 9. Most people that were "opposed" stated their opposition was based on a religious or personal belief that alcohol should not be allowed at all.
- 10. I personally wrote the "Qualitative Summary" found on page 3 of the Blitz Canvassing Report (attached). The Qualitative Summary accurately states my experience circulating the Survey for the Asteria Theatre liquor license application.
- 11. I had intended and was available to attend the originally scheduled liquor license hearing on August 7, 2024. I am unable to attend the liquor license hearing now continued to August 21, 2024. I am out of town that week on a long-planned vacation with family. I can be available by telephone.



A liquor license application permitting sales of malt, vinous and spirituous liquors for consumption at place where sold, was filed with the Local Licensing Authority on June 27, 2024 and on July 24, 2024 a legal notice will be published in the Daily Sentinel and a "Notice of Hearing" was posted on the property.

A survey was conducted by the applicant to address the reasonable requirements of the neighborhood. The neighborhood was defined as the area bounded by Orchard Ave on the north, Gunnison Ave on the south, N 12th Street on the east and N 5th Street on the west and includes both sides of the outer boundary streets. The City Clerk's Office reviewed the findings and obtained the following results (map attached).


