#### **BIBEAU ENCLAVE ANNEXATION**

# LOCATED ALONG D 1/2 ROAD BETWEEN APPROXIMATELY 29 1/4 AND 29 1/2 ROADS

## CONSISTING OF APPROXIMATELY 16.10 ACRES

WHEREAS, on the 4<sup>th</sup> day of September, 2013, the City Council of the City of Grand Junction gave notice that they will consider for annexation to the City of Grand Junction the following described territory, commonly known as the Bibeau Enclave; and

WHEREAS, a hearing and second reading on the proposed annexation ordinance was duly held after proper notice on the 16<sup>th</sup> day of October, 2013; and
