**Minutes of April 1, 2014 Meeting.** Chris Endreson made a motion to approve the minutes of the April 1, 2014 meeting as written. The motion passed unanimously (4-0) on a second by Michael Menard.

### Historic Preservation Month Activities/Events – May 2014

The Board discussed details of the events/activities for Historic Preservation Month. A press release was issued and information is on the events is on the City's VCB calendar of events, the Museum's Facebook page and History Colorado's web page and has appeared in the Downtown newsletter.

- Federal Building Presentation will be May 13<sup>th</sup> 11:00 am at the Main Library Community Room. Tours of the building will follow at 1:00 pm.
- National Train Day is May 10<sup>th</sup>. The public is invited to meet both the morning and afternoon trains with the Friends of the Depot and Amtrak.
- Bennett is also organizing recognition of National Train Day which is May 10<sup>th</sup>. The public is invited to join the Friends of the Depot and AMTRAK in welcoming passengers on the morning and afternoon trains that day.
- Museum, Palisade and Fruita events were also included in the press release. Fruita held a history day April 26<sup>th</sup> and Palisade will be holding a walking tour on May 10<sup>th</sup>. The Museum's events include the May 15<sup>th</sup> oral history program which is a presentation by Jon Maraschin, executive director of the Business Incubator Center, about the history and success of the Center and the opening of a rock art exhibit on May 15<sup>th</sup>.

**Potential Project – Old Jail.** Kristen stated that the old jail between the old courthouse and City Hall is currently vacant and there is interest in preserving and reusing it. Harry Weiss of the DDA is looking at the original floor plans and starting to brainstorm ideas for reuse. The Board discussed potential involvement with the historical research, designation on the City, State and/or National Registers, and grant applications. Kristen will contact Mesa County to schedule a tour of the building for the Board's June meeting.

**North Seventh Street Historic District Inventory.** The Board will set a date to conduct a walking tour of the District to inventory the historic accessory structures some time in June.
