SUBJECT: Sole Source Request for Vectors Inc.

This request is to purchase an additional GPS survey unit for the new City Surveyor position and continue to use Vectors Inc. as the sole source provider for survey equipment & software.

As you are aware, the Engineering Division provides land surveying support for multiple departments. With the amount of capital projects and continued high level of development applications, an additional City Surveyor position was approved in 2024. This position is expected to perform a combination of office and field work, which includes using land surveying equipment. With the new position, the City has a total of 3 surveyor positions (2 PLS & 1 Technician), yet only have on GPS survey unit. Since most of the field work completed by Survey staff in completed using GPS technology, this means that only one surveyor can conduct field work at a time.

Our Surveyors rely heavily on using Mesa County's Geodetic Control Network and base stations, which have run seamlessly with City's Trimble GPS equipment for the last 25+ years. It is imperative that our survey group maintain compatibility with the County's base stations and network, as well as with our current software and equipment, by continuing to use the Trimble product line.

Trimble does not sell retail to the public and we are only able to purchase new Trimble products from authorized vendors.
