**2**nd **Non-Mandatory Pre-Proposal Meeting:** Virtual pre-proposal briefing will be offered to all firms interested in the project/this solicitation. Attending the pre-proposal briefing is recommended for all firms intending to submit a response to this LOI. The briefing will be held **via Microsoft Teams** on **February 26, 2025, at <u>2:30 p.m.</u> Mountain Time**, downloading the app in advance of the briefing is recommended. The purpose of the briefing is to clarify the LOI if there are questions and to answer project-specific inquiries. *Nothing stated during the briefing will modify the solicitation. Any modifications to the LOI will be communicated exclusively through addenda*.

3. **Q:** We received the Addendum No.4 for Salt Flats Development (LOI-5577-25-KN) today, indicating that the deadline has been shifted from 2/21 to 3/10. Is there any consideration for such changes, for example, will the city expect a more comprehensive development proposal with masterplan and building designs?

**A:** The City extended the timeline to allow for more time for vendors to put together proposals. Proposals will still be evaluated on the same criteria / scope stated in the solicitation and addendums.

4. **Q:** Would it be helpful to the City if we submitted our RFI early before the new March 10 deadline? We are ready now. Maybe after the Feb 26 information session?

**A:** The City will not be looking at any responses until the submittal deadline (March 10<sup>th</sup> at 1:00 p.m.). We recommend you hold off on submitting your proposal until the final addendum is posted (refer to the updated timeline in Question 1) so all addendums can be acknowledged.

5. **Q:** I have not been able to find any applications on the website to fill out. So I am supplying this letter as I know the deadline is today. How can we submit a formal application and specifications needed and timelines for designs?

Please make sure you pay attention to the updated timeline provided in Addendum 4 & 5. Also, please make sure that your proposal submitted follows Section 5 Submittal Requirements and Instructions in the solicitation document. All responses shall be submitted through Bidnet.

The original solicitation for the project noted above is amended as noted.
