#### GRAND JUNCTION LIQUOR LICENSING AUTHORITY MINUTES March 5, 2025

#### I. Call to Order

The meeting was called to order at 1:58 p.m. Those present were Hearing Officer Sam D. Starritt, City Attorney John Shaver, and Deputy City Clerk Misty Williams.

Jesse Daniels, managing partner of Good Judy's, was present to answer questions regarding the late filing. He explained that they had a change in office management and bookkeeping staff, and during the transition the renewal had slipped through the cracks. They have implemented a multi-person check list for permits and expense accounts to ensure timely filing in the future. Hearing Officer Starritt asked if anyone was present to speak against the application; there was no one. Hearing Officer Starritt approved the late filing.

The Liquor Licensing Authority took a brief recess at 2:07 p.m. and resumed the hearing at 2:16 pm.

Hearing Officer Starritt asked if there was a representative present from Surf to Turf. John Howe, Attorney for Surf to Turf, as well as Chengle Lin, were present to provide an update on the extensive construction and remodel taking place inside of the premises. They provided progress photos to the hearing officer. They had not received their Certificate of Occupancy at the time of the hearing. They reported that they are approximately 1 month out from finishing the construction. Hearing Officer Starritt requested this license be revisited at the May 7<sup>th</sup>, 2025, Liquor Licensing Authority Hearing, unless the Certificate of Occupancy is obtained before the May 7<sup>th</sup>, 2025, hearing, the State and Local licenses will be released to the applicant at that time.

Hearing Officer Starritt asked Ms. Williams to read the survey results into the record (attached).

Hearing Officer Starritt verified with Ms. Williams the application was in order and asked if anyone was present to speak against the application. There was no one.

Hearing Officer Starritt found the needs of the neighborhood are not being met and found no legal reason to deny the license. The new Hotel & Restaurant license application for Ceviches & Miches, Inc. dba Ceviches & Miches was approved. The City Clerk's Office will prepare a resolution of findings for Hearing Officer Starritt's signature.





On February 15, 2025, a legal notice will be published in the Daily Sentinel.

A survey was conducted by the applicant to address the reasonable requirements of the neighborhood. The neighborhood was defined as the area bounded by Teller Avenue on the north, Colorado Avenue on the south, North 4<sup>th</sup> Street on the east and Baserock Street on the west and include both sides of the outer boundary streets. The City Clerk's Office reviewed the findings and obtained the following results (map attached).

To date, no counter petitions or remonstrances have been filed. Exhibits to survey sheets showed 234 addresses attempted without success, 21 refused to sign, and 18 marked as other.



The exterior boundaries will be roped or with metal barricade fencing. The perimeter does have existing boundaries we are hoping to use.

Ticket holders will have to show their i.d. and receive a wrist band to receive samples of the beer and wine. Each beer and wine vendor will be an employee of the brewery and winery and will be orientated on the wrist band color and expectation.

11. How will the conduct and level of intoxication of attendees be monitored and by whom?

Each participant receives a ticket when they enter, they are only allotted one sample pour from each

brewery and winery. All staff and volunteers will be trained on recognizing those under the influence.

Yes, I have also attended the TIPS training.

Water will be available throughout as well as 10 food vendors.


