This memo is to serve as sole source justification for the procurement of replacement recirculation pump impellers for the anaerobic digesters. We are currently only operating one of two pumps that use these impellers. We need to replace the malfunctioning unit and have an additional unit on hand for immediate replacement if either one fails in the foreseeable future. These pumps are critical in the anaerobic digestion process at the plant.

Denver Industrial Pumps is the current manufacturer of the impellers we use in our system and additional costs would be incurred to retrofit pumps made by another manufacturer.
