Project: City of Grand Junction Community Recreation Center Climbing Wall

Proposers responding to the above-referenced solicitation are hereby advised that certain requirements have been **clarified, modified, supplemented, or superseded** as of the date of this Addendum, as outlined below.

Please take note of the following clarifications:

1. Clarification – Operational Equipment Requirements

In addition to pricing for the fabrication and installation of the indoor climbing wall, Proposers shall include a detailed list of all recommended supplemental equipment necessary for the City to fully open and operate the CRC Climbing Wall. This includes, but is not limited to:

- Ropes
- Harnesses
- TrueBlue Auto Belays
- Climbing holds (specify quantity and color assortment)
- Gear storage systems
- Climbing shoes (variety of sizes recommended)

Each equipment item must include both a **unit cost and the extended cost**, clearly itemized for evaluation purposes.

2. Correction – Numbering in Attachments Section (Section 4.0)

In Section 4.0 – Scope of Work, under Attachment B: Construction Documents for the CRC Indoor Climbing Wall, the numbering was incorrectly shown as Items 6 through 10, instead of 1 through 6.

- The link titled "Panelized Climbing Wall – Final Installation Set" should be labeled as Item 6, not as an unnumbered entry.
- The correct item numbering for Attachment B should read:

3. Correction – Table of Contents

In the **Table of Contents**, the number “6.” was inadvertently omitted in front of **Panelized Climbing Wall – Final Installation Set**.

This addendum modifies the original solicitation document as described above. All other terms and conditions of the solicitation remain unchanged.

Proposers must acknowledge receipt of this addendum by completing the acknowledgment section in **Section 7.0 – Solicitation Response Form**.
